HEAVY EQUIPMENT OPERATOR III – Property & Environmental Services Division

FUNCTION

Under general supervision, is responsible for operation of division related equipment to move load, haul materials and maintain site and to operate the Household Hazardous Waste Facility when necessary. Also, will be responsible for operating Front/Rear Loaders and Roll Off trucks when needed within the Collection and Hauling department to cover vacations and absences. Also performs routine and preventive maintenance and repair on all related equipment, including but not limited to checking fluid levels, tire pressures, etc. Reports to Manager, Property & Environmental Services.

EXAMPLES OF WORK PERFORMED

- Operates all types of heavy equipment to include rear/front loader and roll off truck.
- Responsible for and performs preventive maintenance on equipment operated.
- Responsible for mowing during the mowing season as well as assisting with the food waste composting when needed.
- Assists all positions within department with property maintenance and environmental related tasks.
- Interacts and communicates with various related groups and individuals to include customers, supervisors, co-workers, other Authority personnel, etc.
- Constructs roads, trails and necessary fire lines on SWA property.
- Assists with forest management on approximately 1200 acres of pine and mixed hardwood forest and a 1-3 year burn rotation for wildlife and environmental management practices.
- Inspects all acres of forest for possible wildlife violators, disease of plants and forestry products, the improvement of roads and or trails.

PREFERRED KNOWLEDGE, SKILLS AND ABILITIES

- Must be able to operate a multitude of light and heavy equipment to include but not limited to: loaders, backhoe, bushhog, tractor, dump truck, etc.
- Skilled in the use and upkeep of small tools and equipment.
- Ability to perform manual labor such as lifting and handling of equipment and supplies.
- Must be able to lift/carry up to fifty five pounds.
- Ability to exert up to seventy-five pounds of force to lift, carry, push, pull or otherwise move objects.

- Provides basic general repairs to damaged or inoperative system components.
